Industry Academia Collaboration

Faculty/Resource Personnel from both organizations will collaborate in the supervision of students and in joint training and research in disciplines of mutual interest. All such joint academic activities will be governed by the terms laid out in **Annexure I**.

Commencement, renewal, termination and amendment

This MOU will come into force upon affixing of the signatures of the representatives of the partner institutions and will remain in effect for three years. This MOU may be renewed upon its expiry, with the agreement of both partner institutions. If either partner institution wishes to terminate the MOU at the end of **the three-year period**, it must notify the other institution not less than six months prior to the expiry of the MOU.

This MOU or its renewal and the actions taken under it may be reviewed at any time. Modifications may be made by mutual agreement and any amendment or extension to the agreement may be formalized by the exchange of letters between the two parties.
