If either partner institution wishes to terminate the MOU at the end of the three- year period, it must notify the other institutions not less than six months prior to the expiry of the MOU.

#### Annexure I

## Rules governing Academic Collaboration between two Institutions

- 10.Each institution will nominate one of its members as its representative in-charge of the co-operative program. Individual programs of the work under this Memorandum will be jointly planned and conducted by the nominees of both parties.
- 11. Progress of the work of any individual program will be reviewed and approved by designated authorities of both parties.
- 12. The final approval of any project will depend on the availability of guaranteed support.
- 13. Neither student /faculty will require admission or tuition fees of exchange students under this MOU
- 14. Course credits and grades earned will be determined by the home institution based on the grade report from the awarding institution.
- 15. Participants will be subjected to the rules and regulations of the host institution, in addition to specific rules and regulations, if any.
- 16. The host institution will evaluate the nomination and determine their suitability for selection under any program.
- 17. The host institution will inform the home institution of any technical or other problems that may arise during the period of student's residence in the host institution. The host institution will take appropriate action under its established policy and procedures, in consultation with the home institution to deal with such problems.
- 18. The parent institution will be responsible for the financial budget if any for their respective participants if any.
