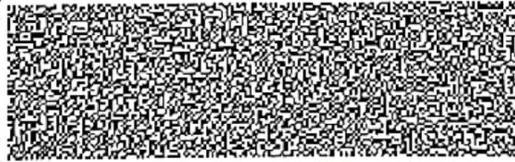
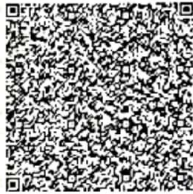

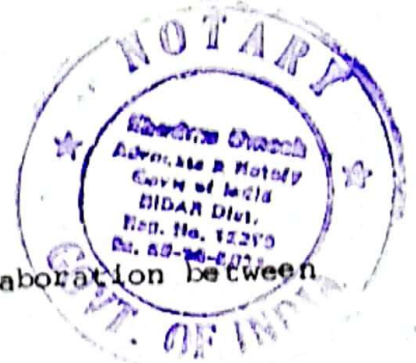

Rules Governing Academic and Research collaboration between

4. In any case, the consent of the teacher / project supervisor / research supervisor is required, such consent will be taken into account among other things whether the student has pre-requisites for the course / project.
5. Neither student / faculty will require admission or tuition fees of exchange students under this MOU.
6. Course credits and grades earned will be determined by the K.P. News institution based on the grade report from the awarding institution.
7. Participants will be subjected to the rules and regulations of the host institution, in addition to specific rules and regulations, if any.
8. The host institution will evaluate the nomination and determine their suitability for selection under any Programme.
