Scope

The Scope of Collaboration on Academic and Research activities in this Memorandum of Understanding includes the following categories:

- Offering of Certificate Courses in the arcas of mutual Interest.
- Academic and Research collaboration in the area of Folklore Culture, Language and Language and Literature.
- Exchange of Resource Persons for Teaching and Training Scholarly information materials and publications
- Jointly organizing Conferences/Seminar/Workshop etc.
- Organising Intership/Training for the Students
- Institutional Social Responsibility (ICR) Activities.



Annexure-1

Rules governing Academic and Research Collaboration between two institutions

- 1. Each institution will nominate one of its members as its representative in charge of the cooperative program, individual programs of work under this Memorandum will be Jointly and conducted by the nominees of both parties.
- 2. Progress of work of any individual program will be reviewed and approved by designated authorities of both parties.
- 3. The final approval of any project will depend on the availability of guaranteed support.
- 4. In any case, the consent of the teacher / project supervisors /research supervisors is required such consent will take into account among other things whether the students has pre-requisites for the course/project.
- 5. Neither student/faculty will require admission or tuition fees of exchange students under this MOU.
- 6. Course credits and grades earned will be determined by the home institution based on the grade report from the awarding institution.
- 7. Participants will be subjected to the rules and regulations of the host institution in addition to specific rules and regulations, if any.
- 8. The host institution will evaluate the nomination and determine their suitability for selection under any programme.
- 9. The host Institution will inform the home institution of any technical or other problems that may arise during the period of student's residence in the host institution. The host institution will take appropriate action under its established policy and procedures, in consultation with the home institution to deal with such problems.
- 10. The parent institution will be responsible for the financial budget if any for their respective participants if any.
- 11. Accommodation should be taken care by the host Institution.

Industry Academia collaboration

Faculty/Resource Personnel from both organizations will collaborate in the supervision of students and in joint training and research in disciplines of mutual interest. All such joint academic activities will be governed by the terms laid out in Annexure – 1

Commencement, renewal, termination and amendment

This MOU will into force upon affixing of the signatures of the representatives of the partner institutions and will remain in effort for five years. This MOU may be renewed upon its expiry. With the agreement of both partner institutions. If either partner institution wishes to terminate the MOU at the end of the five year period, it must notify the other institution not less than six months prior to the expiry of the MOU.

This MOU or its renewal and the taken under it may be reviewed at any time. Modification may be made by mutual agreement and any amendment or extension to the agreement may be formalized by the exchange of letters between the two parties.
