KRE Society's Karnatak Arts, Science and Commerce College, Bidar-585401, KS, India and Guru Nanak First Grade College, Teachers Colony, Bidar - 585403, KS, India have agreed to the following protocols governing their collaboration on academic related activities:

#### **Scope**

The Scope of collaboration on Academic and Research activities in this Memorandum of Understanding includes the following categories:

- Usage of Laboratories and Special Instruments
- Exchange of Resource Persons for Teaching and Training, scholarly information, materials and publications.
- Jointly organizing Workshop etc.

#### **Industry Academia Collaboration**

Faculty/Resource Personnel from both organizations will collaborate in the supervision of students and in joint academic activities in disciplines of





mutual interest. All such joint academic activities will be governed by the terms laid out in **Annexure I**.

### **Commencement, renewal, termination and amendment**

This MOU will come into force upon affixing of the signatures of the representatives of the partner institutions and will remain in effect for five years. This MOU may be renewed upon its expiry, with the agreement of both partner institutions.

If either partner institution wishes to terminate the MOU at the end of the three-year period, it must notify the other institution not less than six months prior to the expiry of the MOU.

This MOU or its renewal and the actions taken under it may be reviewed at any time. Modifications may be made by mutual agreement and any amendment or extension to the agreement may be formalized by the exchange of letters between the two parties.

## **Annexure I**

### **Rules governing Academic Collaboration between two institutions**

1. Each institution will nominate one of its members as its representative in-charge of the cooperative program. Individual programs of work under this Memorandum will be jointly planned and conducted by the nominees of both parties.
2. Progress of the work of any individual program will be reviewed and approved by designated authorities of both parties.
3. The final approval of any project will depend on the availability of guaranteed support.
4. Neither student/faculty will require admission or tuition fees of exchange students under this MOU.
5. Course credits and grades earned will be determined by the home institution based on the grade report from the awarding institution.
6. Participants will be subjected to the rules and regulations of the host institution, in addition to specific rules and regulations, if any.
7. The host institution will evaluate the nomination and determine their suitability for selection under any Programme.
8. The host institution will inform the home institution of any technical or other problems that may arise during the period of student's residence in the host institution. The host institution will take appropriate action under its established policy and procedures, in consultation with the home institution to deal with such problems.
10. The parent institution will be responsible for the financial budget if any for their respective participants if any.
